# 9TH ANNUAL NATIONAL MEMBER FOOD DRIVE IS UNDERWAY

We have just launched our 9<sup>th</sup> Annual National Member Food Drive! Please get involved and help us help the hungry here in the United States this year.

Per the USDA's Economic Research Services' (ERS) Household Food Security report from 2015, 1 in 8 people in the United States (13.4%) struggles with hunger. Food security is defined by the ERS as "access by all people at all times to enough food for an active, healthy lifestyle." Those struggling with hunger, then, are limited by a lack of money and other resources to get adequate food, at least at some point during the year. 4.6% of individuals struggling with hunger are at the very low food security levels.

# **9TH ANNUAL NAT'L MEMBER FOOD DRIVE** CON'T



#### IRS 990N E-POSTCARD FILINGS STARTED IN 2008

Prior to 2007, nonprofits with annual gross receipts under \$25,000 did not have to make any yearly filings with the IRS. But in 2008, the IRS introduced a new form just for small nonprofits: Form 990-N (called the Electronic Notice (e-Postcard) for Tax-Exempt Organizations Not Required To File Form 990 or 990-EZ).

Congress passed this tax filing requirement in response to concerns that smaller nonprofits were not keeping the IRS up to date on new business addresses and changes to other key information. In fact, the IRS suspects that thousands of small nonprofits have closed their doors without notifying the agency.

Although the number of people experiencing food insecurity in 2015 declined significantly from 2014 (15.4% in 2014 to 13.4% in 2015), there are still 42,238,000 people in the United States that need help; over 13,000,000 of which are children. So, although it appears there has been some improvement in the fight against hunger, our National Member Food Drive is obviously still important in helping meet the needs of the food-insecure in this country.

Get your chapter involved! Have a member food drive and do a Food Build; take the cans and boxes of food and other food items collected and build something out of them, like building blocks. Take pictures of your food build throughout the process and one of the final structure and submit those pictures to the home office by December 1, 2017 and earn your local food bank a minimum of \$100 from Assured Life Association.

## **CHAPTER IRS 990N E-FILINGS TO BEGIN THIS MONTH**

The home office will once again file the 990N E-postcard with the IRS on behalf of all chapters this year. We will begin this filing by the end of the month so if your chapter has not completed all of its annual reporting to the Home Office, it is important that you do so as soon as possible. We use chapter reporting as a basis for filing an active status for your chapter with Internal Revenue Service, regardless of the activities or lack thereof. So, as long as you report, we list you active with the IRS.

## **COMMUNITY SERVICE DOWN FROM** LAST YEAR

With 87% of our chapters having reported for 2016, our time and money spent on community service is not looking good. Although our total number of community service events increased from 102 in 2015 to 113 so far reported for 2016, the total community service hours reported thus far decreased by 621 hours. Our total chapter charitable contributions and scholarships is currently \$105,432; down 44.5% from last year! Granted, we still have 7 chapters to report, but the numbers are not going to increase significantly upon receipt of all reporting. Here is how the last 2 years compare:

#### INCREASING OUR COMMUNITY SER-VICE FOR 2017

Our goal for 2017 should be to increase our community service events, hours and monetary contributions. Most chapters report a good number of member social events each year (even though those numbers are down for 2016 as well). If we could convert just 25% of those member social events to community service, we would bump up our community service by 41 events and 5,200 hours from 2016. That's significant.

One way to accomplish this feat is for every chapter to commit to a member food drive for your local food bank. Its easy to do, especially if you are already getting together socially anyway.

Or maybe you would rather participate in Operation Santa's Elves and seek out a local toy drive for your chapter to help with. Either way, your members and community will benefit. Let's make 2017 a stand-out year!

#### OVERALL CHAPTER AC-TIVITIES ON THE DE-CLINE

It appears that, overall, chapters are not as active as we used to be. In fact, 2016 reported activities are the lowest in history; at least for the last 12 years.

Perhaps this is due to our membership getting older and being less mobile. Or perhaps 5 chapters closing in 2015 & 2016 has something to do with it. Or maybe it is a combination of both.

Another reason could be less than accurate reporting. It is easy to miss counting a meeting or event or two. To better track your activities, you should consider utilizing the online chapter activity tracking form. After every meeting and event, enter the information applicable to the event online and submit. The home office will keep a tally of all your meetings and events throughout the year.

At the end of the year, the home office will already have your chapter's activities report for the entire year. Try it. Go to assuredlife.org and click on the Chapter Leaders link at the top. Then select Online Chapter Activity Tracking System.

# CHAPTER FRATERNAL SOCIAL & FELLOW-SHIP EVENTS AND HOURS DECREASE

Along with community service, fraternal social/fellowship activities and hours decreased in 2016; at least according to the chapter reporting to date. The number of business meetings was down by 63 meetings from what was reported in 2015 and total hours spent for chapter business meetings decreased by 2,682 hours compared to 2015.

Member social events and activities decreased by 48 events from 2015 with the hours spent on those events and activities decreasing 8,889 hours. Again, we still have 7 chapters to complete their reporting for 2016, but we don't see these statistics changing

significantly. The total amount chapters spent on fraternal operations and activities last year was \$288,824 compared to \$337,769 in 2015.

The 2016 Fraternal Year in Review will be published at the completion of all chapter reporting and will be made available to you at that time.
